**Risk Management Workshop between
TWG-ASW and CECWG**




The Workshop on Risk Management and Pre-Arrival Customs Clearance Procedures using Single Window Data, Yangon, Myanmar, on 7 May 2018

- The workshop was attended by all Members of TWG ASW – except Brunei Darussalam and Cambodia, and 22 representative from CECWG
- NOTED that the workshop was conducted in partnership with the US-ASEAN Connectivity Through Trade and Investment (US-ACTI) to discuss the possible use of the ASEAN Single Window (ASW) platform to introduce risk management to support pre-arrival customs clearance in the region by using Single Window data
- DISCUSSED, amongst others:
 1. overview of the operationalisation of the ASW system, its benefits and key challenges;
 2. international standards concerning risk management and pre-arrival clearance;
 3. benefits and key challenges of risk management issues and implementing pre-arrival clearance of AMS NSW; and
 4. sharing the best practices on using advance data and information for risk management and addressing security policy.

- NOTED AMS' presentation of their updates on the preparation and implementation of risk management and pre-arrival clearance in their national level.
- HIGHLIGHTED the need of taking advantage of having the data in advance for risk management purposes, regardless the different system being used by each AMS, and ENCOURAGED AMS to commit to standardise the data and information with international standard that would be exchanged under the ASW enabled infrastructure.
- TASKED the TWG to have further deliberation on the above-mentioned matters and sought come up with the recommendations and solutions for risk management approach for ASEAN, as well as the strategic approach and enhancement of the ASW platform.

Monitoring and Evaluation to the workshop

Highlights included:

- All respondents thought workshop was good or excellent. Meanwhile all respondents strongly agree (55%) or agree (45%) the presenters were knowledgeable about workshop topics and workshop had clear and met its objectives.
- When asked about topic relevance and its application at work, 90% of respondents said they would either often or occasionally apply what they have learned in their professional responsibilities.

Figure 1. Overall Rate of Workshop

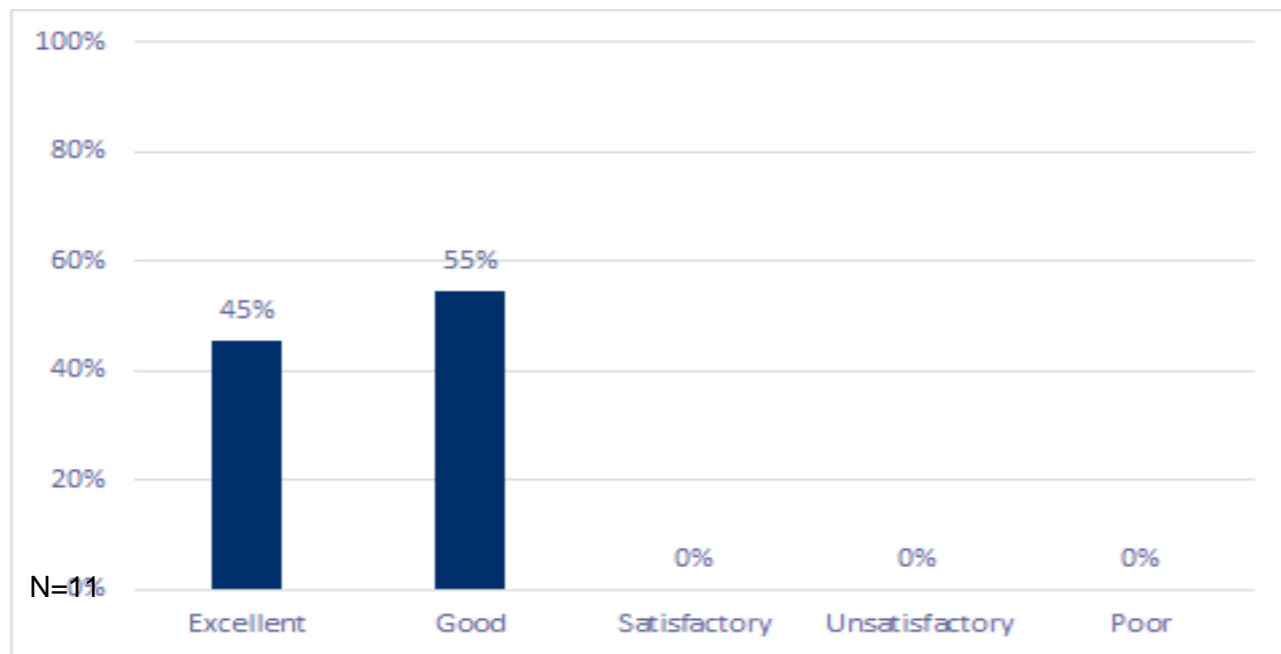


Figure 2. Training Relevance to Job Responsibilities

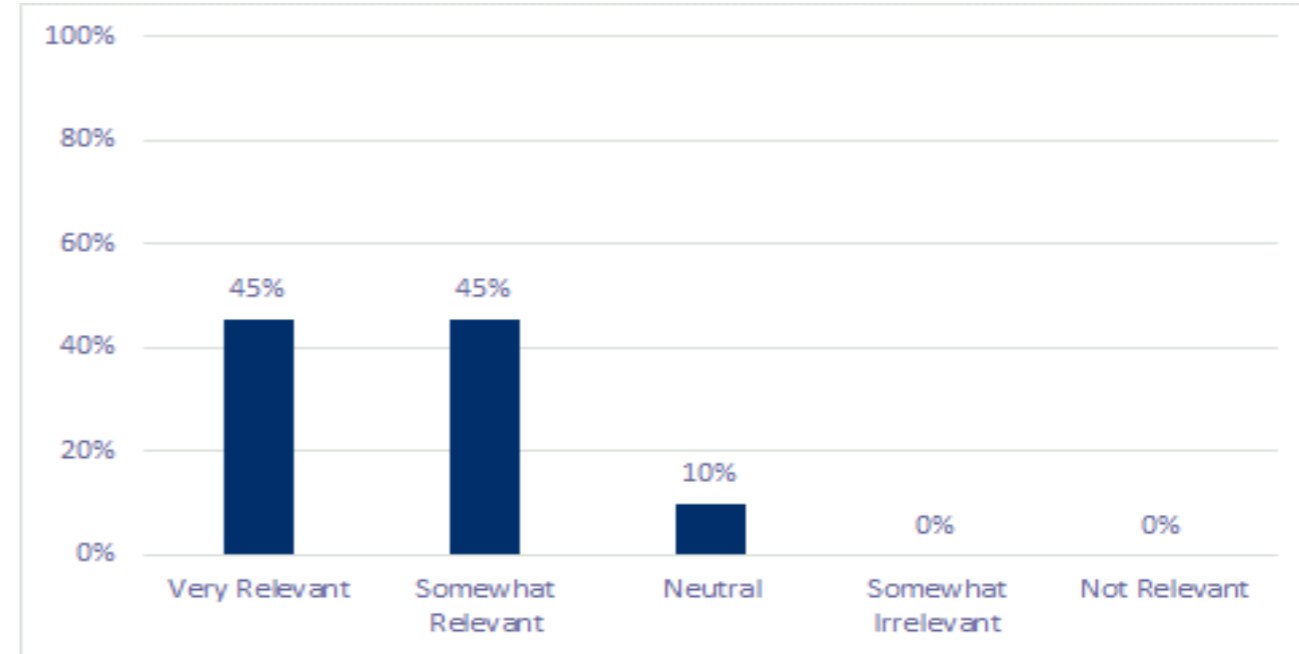
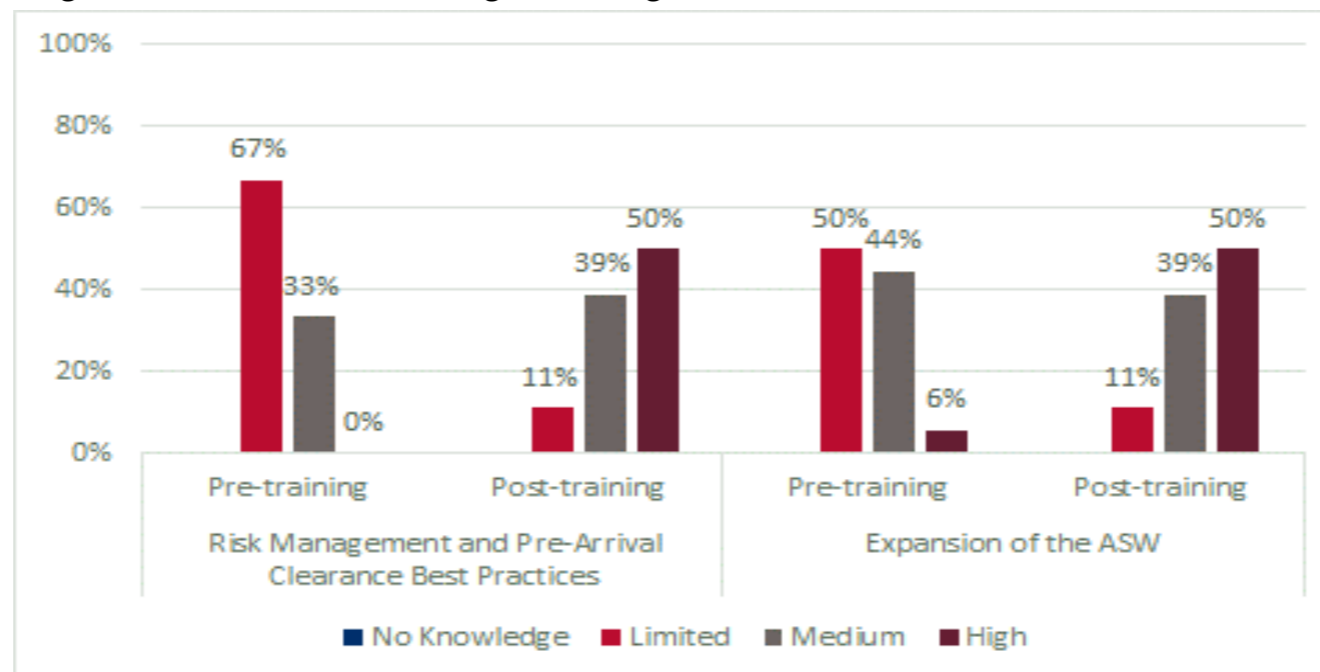



Figure 10. Pre- and Post-training Knowledge Level
